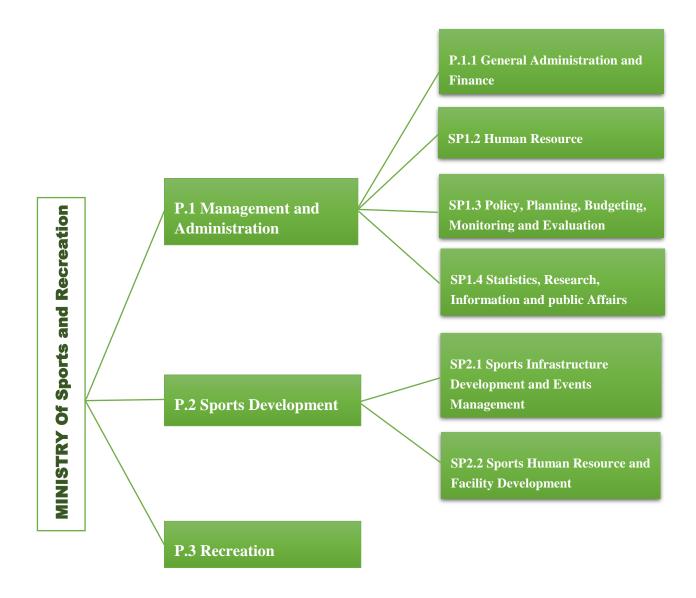

# PART A: STRATEGIC OVERVIEW OF THE MINISTRY OF SPORTS AND RECREATION

#### 1. MANDATE

In line with Executive Instrument (E.I. 1), January 2025 (Civil Service (Ministries) Instrument, 2025) and section 11 and 13 of the Civil Service Law (PNDCL 327), the Ministry of Sports and Recreation is mandated to formulate and implement government policies for the Sports and Recreation sector.

#### 2. VISION

Enhanced sports and recreation environment for personal well-being, international competitiveness and national development.

#### 3. MISSION

The Ministry of Sports and Recreation exists to develop, promote, and sustain accessible and inclusive sports and recreational partnership and opportunities through strategic policies and programs to enhance individual well-being, foster national unity, and achieve excellence at local and international levels.

#### 4. POLICY OBJECTIVES

The three (3) Policy Objectives of the Ministry of Sports and Recreation are as follows:

- Enhance sports and recreational infrastructure for all.
- Build capacity for sports and recreational development.
- Ensure sustainable funding sources for growth and development of sports.

#### 5. GOAL

To contribute to the attainment of national integration, sustained macro-economic stability, peace, healthy population and SDGs through promotion of sport for development and recreation.



#### 6. CORE FUNCTIONS

The Ministry's core functions are to:

- Formulate, implement, and review national policies, strategies and framework for development of sports infrastructure, talents and human resources and governance and administration ethics.
- Facilitate the development, maintenance and equitable distribution of sports and recreational facilities across the country
- Ensure the identification, nurturing and support for sports and recreational professionals to achieve excellence at local and international levels.
- Provide a framework for training and capacity-building of sports personnel, including coaches, referees and administration
- Develop a framework to promote, market and regulate domestic sports and recreation.
- Represent the nation in international sports forums, foster partnerships with global sports bodies, and promote international sports diplomacy.
- Mobilise resources for sports development and infrastructure, manage grants and sponsorships and ensure efficient use of funds in sports and recreation projects.
- Advocate for active lifestyle and the integration of sports and recreation into the public health programmes.
- Establish monitoring and evaluation mechanisms to access the impact and performance of sports and recreational programmes
- Organise and coordinate national and international sports events to enhance national pride and global competitiveness.
- Conduct research to inform policies and programmes and promote the use of technology and innovation in sports and recreation.
- Promote grassroots sports and recreational activities to foster community cohesion, health and well-being.
- Ensure equitable participation in sports and recreational activities, with a focus on gender equality, persons with disabilities and undeserved communities

# 8. EXPENDITURE TREND OF THE MINISTRY OF YOUTH AND SPORTS

For Budget year 2022, an amount of Three Hundred and Eighteen Million, Three Hundred and Twenty Nine Thousand Ghana Cedis Only (GH¢ 318,329,000.00) was allocated to the Ministry. Out of this amount, Twenty Six Million, Five Hundred and Fourteen Thousand Ghana Cedis (GH¢26,514,000.00) was allocated for Compensation of Employees, Goods and Services comprised Twenty Eight Million, Six Hundred and Eighty Seven Thousand Ghana Cedis (GH¢28,687,000.00). CAPEX was allocated an amount of Fifty Five Million, One Hundred and Ten Thousand Ghana Cedis Only (GH¢55,110,000.00). Four Hundred and Seventy Nine Thousand Ghana Cedis (GH¢479,000.00) was allocated as Internally Generated Funds and Two Hundred and Seven Million, Five Hundred and Thirty Nine Thousand Ghana Cedis Only for Development Partner (DP) Funds (GH¢207,539,000.00).

During the 2022 mid-year fiscal policy review, the Ministry's allocation for Goods & Services and CAPEX were revised to Seventy Eight Million, Six Hundred and Eighty-Seven Thousand Ghana Cedis Only (GH¢78,687,000.00) and Five Million, One Hundred and Ten Thousand Ghana Cedis Only (GH¢5,110,000.00) respectively. Compensation, IGF and DP funds of the Ministry remained unchanged.

The Ministry and its Agencies were allocated an amount of Three Hundred and Ninety-Five Million, Seven Hundred and Twenty – Three Thousand, Two Hundred and Sixty-One Cedi (GH¢395,723,261.00) in 2023 budget year to execute all planned programmes and activities. Compensation of employees comprised, Twenty Eight Million, One Hundred and Four Thousand, Eight Hundred and Forty Cedis (GH¢28,104,840.00). Goods and Services and Capex were allocated Fourteen Million, Seven Hundred and Four Thousand, Five Hundred and Seventy-Five Cedis (GH¢14,704,575.00) and One Million, Six Hundred and Seventy-



Nine Thousand, Seven Hundred and Forty-Seven Cedis (GH¢1,679,747.00) respectively. Approved Internally Generated Funds for the Ministry was Three Million, Six Hundred and Thirty-Four Thousand and Ninety-Nine Cedis (GH¢3,634,099.00) and Three Hundred and Forty Seven Million, Six Hundred Thousand (GH¢347,600,000.00) was approved as development partners funds for the construction of sporting facilities for the 13<sup>th</sup> African Games, Accra 2023.

#### **2024 Budget Allocation**

The Ministry and its Agencies were allocated an amount of One Hundred and Ninety-Five Million, Seven Hundred and Ninety – Five Thousand, Nine Hundred and Seventy-Three Cedis (GH¢195,795,973.00) in 2024 budget year to execute all planned programmes and activities. Compensation of employees comprised, Thirty-Seven Million, Eight Hundred and Thirty-Three Thousand, Nine Hundred and Six Cedis (GH¢37,833,906.00). Goods and Services and Capex were allocated One Hundred and Four Million Cedis (GH¢104,000,000.00) and Fifty Million Cedis (GH¢50,000,000.00) respectively. Approved Internally Generated Funds for the Ministry was Three Million, Nine Hundred and Sixty-Two Thousand and Sixty-Seven Cedis (GH¢3,962,067.00). Total Releases for the Ministry at the end of the 2024 financial year amounted to One Hundred and Ninety-Four Million, Five Hundred and Forty-One and Hundred Eleven Cedis Thousand. Six and Fifty-Four Pesewas (GH¢194,541,611.54) and Actual Expenditure amounted to One Hundred and Ninety-Three Million, Three Hundred and Eighty Thousand, One Hundred and Sixty Cedis and Forty Pesewas (GH¢193,380,160.40).



#### 9. SUMMARY OF KEY ACHIEVEMENTS IN 2024.

The Ministry achieved the following in 2024 under the three (3) programmes (Management & Administration, Youth Services and Sports Development) before its realignment in accordance with Executive Instrument (E.I 1, 2025)

#### MANAGEMENT AND ADMINISTRATION PROGRAMME

#### Successful Hosting and Organisation of the 13th African Games

Ghana successfully hosted and organised the 13th African Games, Accra 2023 from 4th to 23rd March 2024. In all, fifty-three (53) African countries participated in the Games.

Team Ghana was represented at the Games by 495 participants, this was the largest contingent of athletes and officials Ghana has ever presented to the African Games. Twenty-nine (29) sports codes/disciplines were used for the Games out of which eight (8) were Olympic Qualifiers, fifteen (15) Non-Olympic Qualifiers and six (6) Demonstration Sports.







#### **Team Ghana's Participation**

Team Ghana participated in twenty-three (23) sports disciplines and placed sixth on the medal table with sixty-nine (69) medals.

#### **Ghana National Anti-Doping Act**

Ghana is among one of the forty-three (43) African countries which have ratified the United Nations Educational, Scientific and Cultural Organisation (UNESCO) International Convention against doping in Sports. To promote clean sports, the Ghana National Anti-doping Act, 2024, ACT 1116 was passed by Parliament in February 2024.

#### PERFORMANCE OF NATIONAL TEAMS

#### **Black Challenge**

The Black Challenge of Ghana successfully participated in the 2024 African Amputee Football Cup of Nations, Egypt from 18th to 30th May 2024 and won the tournament.

This win has secured the team a spot at the 2026 Amputee World Cup Tournament.





#### Black Stars - 2026 World Cup

The Black Stars of Ghana played their qualifying matches towards the 2026 World cup qualifiers against Mali on 6th June and Central Africa Republic on 10th June 2024.

The Team is currently placed 2<sup>nd</sup> in Group I and competing with Chad, Mali, Central African Republic, Comoros and Madagascar

#### **Black Princesses**

The Black Princesses participated in the 2024 U-20 Women's World Cup Tournament in Columbia from Saturday, August 31st - Sunday, September 22nd 2024.

The Black Princesses competed in Group E against Austria, Japan and New Zealand but exited at the Group Stage.

#### **Black Stars - 2025 AFCON**

The Ministry facilitated the Black Stars of Ghana to play their 2025 qualifying matches towards the 35th Edition of the AFCON Tournament.

The team competed with Angola, Niger and Sudan in Group F; however they did not qualify for the 2025 AFCON Tournament

#### **Monitoring and Evaluation**

The Ministry embarked on monitoring visits to Baba Yara, Essipong, New Edubiase, Accra, Cape Coast and Abiriw Sports Stadia to ascertain the progress and quality of work done as well as agree with stakeholders on the way forward for the successful completion of projects.

#### **Construction of Astroturfs**

Construction and commissioning of Astro turfs at Kunkwa, North East Region and Goaso, Ahafo Region have been completed and made available for use.

#### YOUTH SERVICES PROGRAMME

#### **2024 African Prosperity Dialogues**

A youth leaders forum was organised on 26th January 2024 under the auspices of the African prosperity network and the African Continental Free Trade Area (AFCFTA) secretariat as part of the "African Prosperity Dialogues: 2024" at the Peduase Presidential Lodge.

One hundred and twenty (120) youth comprising youth leaders, young entrepreneurs, youth groups and student groups in the Greater Accra Region participated in the forum to share opportunities, experiences and best practices in addressing challenges facing youth participation in the African trade.



#### Sexual and Reproductive Health and Rights (SRHR) - Survey

A survey was conducted in January 2024 on Two hundred and twenty-seven (227) young people to ascertain their knowledge on Sexual and Reproductive Health and Rights (SRHR) and related issues.

This was undertaken through a collaborative project between the National Youth Authority and United Nations Educational, Science and Cultural Organisation (UNESCO).

This served as a baseline for further awareness creation programme under the Youth Reproductive Education through Awareness, Communication and Health Promotion (Y-REACH) Project

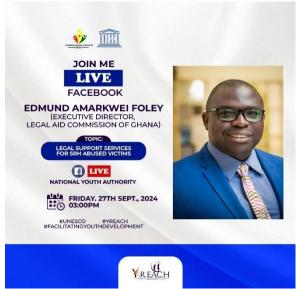
#### Y-REACH Project

Youth Reproductive Education through Awareness, Communication and Health Promotion (Y-REACH) Project, is a collaborative project between the National Youth Authority (NYA) and United Nations Educational, Science and Cultural Organisation (UNESCO) and aimed at providing knowledge and information on Sexual and Reproductive Health and Right (SRHR) to young people via social media. Activities organised under the project included:

- Online Needs Assessment Survey for 345 young people across the country to ascertain young people's knowledge on SRHR and related issues in January **Y-REACH**, 2024.
- Capacity building on content creation on SRHR issues for seventy (70) young social media influencers across the country from 7<sup>th</sup> 9<sup>th</sup> March 2024 at the Bedtime Hotel, Koforidua.
- Provision of data bundles to seventy (70) social media influencers to promote SRHR Issues including provision of basic counselling and referrals when needed.
- Provision of SRHR content for posting as well as live Facebook discussions.

So far, over six million young people have been reached with information and knowledge on SRHR







#### **Adolescent Sexual and Reproductive Health Sensitisation**

- 313 students were sensitised on issues relating to Adolescent Sexual Reproductive Health and truancy and its impact on academics at Wesley Methodist JHS, Sekondi on July 17, 2024.
- 300 final year students of Yabram Community Day School were reached with information on drug and substance on 26th July 2024 in Oti Region.
- 128 vulnerable students and teachers were sensitised on Adolescent Sexual Reproductive Health and truancy and its negative impacts on academic work and general wellbeing at St John the Baptist JHS, Essaman on August 13, 2024.
- 700 students were sensitised on Reproductive Health and HIV/AIDS at the Koforidua Secondary Technical School on 15<sup>th</sup> August 2024.
- 250 Youth were sensitised and imparted with relevant knowledge on adolescent Reproductive Health and HIV/AIDS on 21<sup>st</sup> August 2024 at Bogoso, Western Region.
- 220 young females were sensitised on Menstrual Hygiene at Asankran-Breman on 28<sup>th</sup> August 2024 in the Western Region.
- 403 young females in Asuogyaman, Eastern Region were sensitised on Menstrual Hygiene on 23<sup>rd</sup> September 2024 and 2<sup>nd</sup> November 2024 respectively.
- 510 young girls from four (4) selected Junior High Schools in the Eastern Region were sensitised on Menstrual Hygiene on the 2<sup>nd</sup>, 16<sup>th</sup> and 22<sup>nd</sup> October, 2024 respectively.

#### **Breast Cancer Awareness**

- 800 participants attended the Breast Cancer Awareness education programmes organised at Eguafo Abrem Senior High School on 23<sup>rd</sup> October 2024 by the Komenda-Edina-Eguafo-Abirem (KEEA) Secretariat of the National Youth Authority.
- 250 participants attended the Breast Cancer Sensitisation and Screening Programme organised on 30<sup>th</sup> October 2024 at Agona Nyarkrom by the Agona West Municipal Secretariat. The programme entailed a walk, screening and seminar.

#### **Youth Pavilion**

The Women, Gender and Youth Directorate (WGYD) of the African Union Commission (AUC) in collaboration with the Ministry of Youth and Sports, the African Union Sports Council, Local Organising Committee of the 13th African Games and key development partners organised a five (5) day youth pavilion session as a side event for the African Games for young people across Africa and beyond from 9th to 13th March 2024.

Participants were from Ghana, Ethiopia, Nigeria, Cote d'Ivoire and Saudi Arabia among others. The youth pavilion empowered over 500 young people through masterclasses, experience-sharing, entrepreneurship, policy dialogues, and group work sessions to advance knowledge and



information dissemination on different youth programmes and cultivated networking opportunities.



#### **District Skills and Entrepreneurship Roadshow**

8,056 young people benefited from the "*District Skills and Entrepreneurship Roadshow*", a collaborative project between the National Youth Authority and Africa Skills Hub Foundation (ASH) aimed at providing employability skills training to young people in eleven (11) selected Regions (Greater Accra, Eastern, Oti, Volta, Ashanti, Bono East, Bono, Ahafo, Central, Western and Western North) across the country

#### **Empowering the youth through Entrepreneurship**

433 young people benefited under a collaborative project between UNDP and NYA dubbed "Empowering the youth through entrepreneurship". The project which was implemented in ten (10) Regions with at least forty (40) beneficiaries from each selected Region was geared towards equipping young people with entrepreneurial skills to take advantage of opportunities in AfCFTA. Project activities included the following:

- Orientation workshop for both Regional Directors and District Directors
- Baseline Survey
- Trainer of Trainers Workshop
- Training Workshop for selected beneficiaries







#### Orientation and Mobilisation of Young Entrepreneurs

The National Youth Authority in collaboration with Africa Skills Hub Foundation oriented one hundred and ninety-nine (199) district officers from eleven (11) Regions on 24th April 2024. The orientation led to the development of a road map to mobilise young entrepreneurs within the agriculture value chain to equip them with business skills. The training is currently ongoing Nationwide with over 3,500 beneficiaries.

#### **Development of a National Action Plan on Youth Peace and Security**

A multi-stakeholder dialogue was held for State and Non State Actors within the peace and security ecosystem to initiate the development of a National Action Plan on Youth Peace and Security.

Subsequently, a 26 member Technical Working Group was inaugurated by the Minister of Youth and Sports at the Country Office of UNFPA on 28th May 2024 and tasked accordingly.

#### **Promotion of Safe Menstrual Hygiene**

Three hundred (300) students from the Kaneshie Cluster of Schools were sensitised on Menstrual Hygiene and given free sanitary pads on 29th May 2024 to commemorate the 2024 International Menstrual Hygiene Day.





#### **Establishment of a Youth Sector Working Group**

The National Youth Authority in collaboration with British Council Ghana, organised an inaugural breakfast meeting on 11th June 2024 at the British Council Conference Hall to initiate a discussion with key players in the youth development sector towards the formation of the Youth Sector Working Group. The meeting was chaired by the Minister of Youth and Sports Hon. Mustapha Ussif.

The task force have developed a draft framework for the structure and governance of the working group, yet to be validated by key stakeholders in youth development space.

#### **National Youth Conference**

The National Youth Authority in partnership with Alliance for Green Revolution for Africa (AGRA) held the 3rd Edition of the National Youth Conference at the Pentecost Convention Centre (PCC) Gomoa Fetteh from 11th -12th August, with a climax programme at the Alisa Hotel on 13th August, 2024.

The conference was themed "from clicks to progress: youth digital pathways for sustainable development", with 2,000 participants drawn across the sixteen (16) Regions of the country.





#### **Youth Peace Campaigns**

- 5,000 young people in Koforidua, Kwahu West and Yilo Krobo in the Eastern Region were sensitised on Youth Peace and Security for the upcoming elections via Community Peace Walks and Radio Discussions.
- 60 young people in Koforidua were trained as Youth Peace Ambassadors to advocate for peace and security in the upcoming elections on 8th November 2024.
- A Peace Football Gala was organised for 190 youth in the Tarkwa Nsuaem Municipality to instill the message for peace before, during and after the 2024 elections.
- 563 young people were oriented on the need for peace during the elections on 11<sup>th</sup> October 2024 at the Lighthouse Church, Sunyani.
- 50 youth were trained in peace building and conflict prevention in the Garu District on 15th July 2024.
- 1000 youth were engaged in Peace Walk in Wa, Upper West Region on 23<sup>rd</sup> November 2024
- Agona West Municipal NYA Secretariat in collaboration with National Commission for Civic Education (NCCE), Ghana Education Service (GES) and Compassion International Ghana organised a Peace Walk in Agona Swedru on 13th November 2024 with 150 young people in attendance.





#### **Commonwealth Year of Youth Project**

Capacity Building Workshop – A one day capacity building workshop on Climate Change and Environmental Sustainability was organised for 200 young people within the Climate Change Ecosystem on 7<sup>th</sup> October 2024 at the Sunlodge Hotel. The workshop aimed at equipping participants with the requisite skills and knowledge on Climate Change while initiating the process to consolidate efforts by young people in Climate Action.

**National Youth Conference -** The 2<sup>nd</sup> National Youth Conference on Climate Change was held at Sunlodge Hotel on 7<sup>th</sup> October 2024. A public lecture on the theme "*Youth-Driven Innovations for Climate Action: Bridging Ambition and Implementation* was presented by Dr. Emmanuel Marfo, Chairperson, Parliamentary Select Committee on Environment, Science and Technology

**Mass public education and advocacy -** A one month radio discussion on Climate Change was held at Tarkwa FM, Western Region and Duapa FM, Ashanti Region respectively.





#### Skills Towards Employability and Productivity (STEP)

The National Youth Authority in collaboration with Aseda Foundation organised an apprenticeship and skills training programme on 20<sup>th</sup> October 2024 for 120 youth in various skills-sets including cake making, beads making, makeup and household chemicals in the Western Region.

30 young beneficiaries in Kwahen-Krom in the Central Region underwent training in Soap making using Cocoa Pod Husk from 6<sup>th</sup> to 7<sup>th</sup> November 2024.

In collaboration with the International Youth Fellowship, 100 young beneficiaries in the Eastern Region were trained in dress making, hair dressing, catering, beads making, soap making and barbering.





#### Election of Joshua Kpodjie Opey as Chairperson of Commonwealth Youth Council

The National Youth Authority supported Joshua Kpodjie Opey, to win the Chairperson of the Commonwealth Youth Council. This comes as a major achievement for the National Youth Authority as Joshua Kpodjie Opey is the first Ghanaian to Chair the Commonwealth Youth Council.





#### **Pan African Youth Forum**

The Authority supported two (2) officials to participate in the Pan African Youth Forum held in Oran, Algeria from 1<sup>st</sup> to 4<sup>th</sup> November 2024.

The Forum served as a platform to engage young people in critical discussions that consequently, equips them with the needed tools to address educational challenges, while reinforcing their roles in achieving sustainable development and peace across the continent.



#### 16 Days of Activism against Gender Based Violence Commemoration

The Eastern Regional Secretariat of the National Youth Authority in collaboration with Star Ghana commemorated the 16 Days of Activism period with the following activities:

- Radio discussions on Eastern FM on the theme: *Empowering Youth: Ending Gender Base Violence* on 29th November 2024.

#### SPORTS DEVELOPMENT

In the area of Sports Development, the National Sports Authority and the National Sports College, Winneba undertook the following developmental activities at the District, Regional, National and International levels in fulfillment of their mandate.

#### Construction of Sports Facilities for the 13th African Games

The International Standard Multi-complex Sports facility at Borteyman was completed and commissioned in February 2024 for the 13th African Games. The Sports facility includes:

- 1000 seater capacity Aquatic Centre with ten (10) lane competition and warm-up Pools;
- Four (4) open tennis courts;
- 1000 seater capacity enclosed tennis Court;
- 500 seater capacity Multipurpose Dome;
- 1000 seater capacity Multipurpose Hall;
- Two (2) storey Administrative Block with two (2) conference rooms;
- Football Pitch with six (6) lane warm-up track; and
- Children Playing Area



#### Construction and Rehabilitation of Auxilliary Facilities for the 13th African Games

Sports Facilities at the University of Ghana Sports Stadium with Athletics Warm-up Track, Theodosia Okoh Hockey Pitch and Cricket Pavilions at the Achimota School Oval were also upgraded and commissioned in February 2024 for use during the 13th African Games.

An International Standard Rugby Pitch was constructed at the University of Ghana for the 13th African Games.

#### National Schools Athletics Championship (NASAC)

Ghana Athletics in partnership with Citi TV launched the novel National Schools Athletics Championship (NASAC) on 9th January 2024 to promote and develop athletics through school sports. The Event brought together over one thousand (1000) student-athletes from across the country at the newly renovated UG Sports Stadium.

#### **4-Nation Junior Athletics Championships**

The National Athletics Team placed 3<sup>rd</sup> and won a total of eighteen (18) medals comprising of eleven (11) gold, six (6) silver and one (1) bronze at the 4-Nation Junior Athletics Championships held at the Stade Félix Houphouët Boigny, Abidjan, Cote D'Ivoire from 19th to 21st April 2024. Participating countries were Cote D'Ivoire, Ghana, Benin and Burkina Faso.

#### **International Fitness and Bodybuilding Federation (IFBB)**

The Ghana Bodybuilding and Fitness Association (GBFA) hosted the 3rd edition of the International Fitness and Bodybuilding Federation (IFBB) West Africa championship on 27th April 2024 at the Ga Mashie Hall of the Trust Sports Emporium, in Accra. The Championship involved eight (8) countries namely Tanzania, Niger, Liberia, Sierra Leone, Togo, Burkina Faso, Ivory Coast and Ghana with a total of thirty-five (35) participants.

Team Ghana won two (2) Gold medals and one (1) silver medal.



#### Ghana National Petroleum Cooperation (GNPC) Ghana's Fastest Human competition

The GNPC Ghana's Fastest Human competition was organised in the under listed Regions;

- Northern Region, Tamale 11<sup>th</sup> May 2024
- Central Region, Cape coast 25<sup>th</sup> May 2024
- Ashanti Region, Kumasi 15<sup>th</sup> June 2024

The competition sought to unearth sporting talents among young people and increase the number of sprint champions in the country. Athletes competed in U15 boys -100m, U15 girls -100m, U18 boys -100m, U18 girls -100m, senior boys -100m and senior girls -100m.



#### Confederation of African Athletics (CAA) Region II Athletics Championship

Ghana placed 2<sup>nd</sup> and won a total of twenty-four (24) medals comprising ten (10) gold, eight (8) silver and six (6) bronze at the Confederation of African Athletics (CAA) Region II Athletics Championship held at the University of Ghana Sports Stadium from 3<sup>rd</sup> to 6<sup>th</sup> June 2024.

Participating countries included Ghana, Benin, Burkina Faso, Cote D'Ivoire, Liberia, Mali, Nigeria, Senegal, Sierra Leone and Togo.

#### **Oseikrom Street Boxing**

The National Sports Authority (NSA) Ashanti Regional directorate in collaboration with the Ghana Boxing Authority hosted the Oseikrom Street Boxing 'Bantama Edition' on Saturday 22nd June 2024 at the Bantama Cocoase Astroturf.





#### **International Cricket Council (ICC) U19 Tournament**

The National Cricket Men's Team placed third (3rd) at the International Cricket Council (ICC) U19 Men Cricket World Cup African Division 1 Qualifier in Dare Salam, Tanzania from 29th July to 12th August 2024.

Eight (8) countries including Ghana, Tanzania, Nigeria, Sierra Leone, Rwanda, Malawi, Botswana and Mozambique participated

#### 2024 Olympic Games and Paralympic Games

Ghana Participated in the 2024 Olympic Games and Paralympic Games in Paris, France from  $28^{th}$  July to  $11^{th}$  August 2024 and  $28^{th}$  August  $-11^{th}$  September 2024 respectively. The Team did not win any medal.

The Ghana Hockey Association collaborated with Umpires International to organise a Virtual training programme for Coaches from 11th to 12th July, 15th to 16th August and 11th to 12th September 2024.

Four (4) coaches and umpires were certified after the workshop.

#### **National Fitness Instructors Course**

The National Sports Authority in collaboration with National Sports For All Ghana (NASFAG) organised a National Fitness Instructors Course (Intermediate & Advanced) for fourteen (14) fitness personnel comprising eleven (11) males and three (3) females at the National Sports College, Winneba from 9th to 13th September, 2024.

### 2. Budget Sub-Programme Description

This sub-programme is delivered by the National Sports College, Winneba. It seeks to train sports personnel, athletes, identify talents in tennis, football and other sporting disciplines.

It also seeks to provide camping facilities for the country's sportsmen and women. It does this by developing training content and organising courses for various sports disciplines, identifies young boys and girls and take them into residential academy programmes where they are given regular academic education as well as sports training.

The sub-programme engages and works in collaboration with other local and international entities with similar objects. It also accommodates and makes available camping and training facilities for national sports contingents and private sports groups.

The beneficiaries of the Sports Human Resource and Facility Development subprogramme include:

- Sports Development Officers;
- Teachers of Ghana Education Service;
- Coaches of various sports associations;
- Tertiary Institutions especially Physical Education Students of University of Education, Winneba;
- Young talents, especially from underprivileged backgrounds;
- GFA Football Clubs;
- Local Keep Fit entities;
- National Sports Contingents.

The technical department of the National Sports College together with all the other support services are involved in the delivery of the programmes. Altogether, thirty-five (35) officers are involved in programme delivery and is funded by Government of Ghana.
